

IAM Patent 1000 Recognizes 37 Perkins Coie Attorneys as Top Practitioners and Names Perkins Coie a Patent Leader in US and China

SEATTLE (June 30, 2020) – Perkins Coie is pleased to announce that the firm and 37 of its intellectual property attorneys were recognized by *Intellectual Asset Management (IAM)* in the 2020 *IAM Patent 1000* list, which recognizes the world's leading patent professionals who are the best-in-class in patent prosecution, licensing, and litigation. The firm was again ranked nationally in the United States for patent litigation and earned new national rankings in the United States for patent prosecution and in China for overall patent law.
