



On Thursday, March 9, 2023, Perkins Coie hosted a highly interactive CLE [webinar](#) that garnered nearly 400 attendees titled: *The Delicate Task: How to Conduct a Trauma-Informed, Survivor-Centered Internal Investigation*. The CLE program was moderated by [T. Markus Funk](#) and featured U.S. District Judge Virginia M. Kendall, University of Colorado-Boulder Chief Operating Officer (and former General Counsel) Patrick O'Rourke, and [Chris Wilkinson](#).

The speakers shared best practices and their experiences investigating cases of workplace violence, sexual and racial trauma, and other instances of power-based harm.
